

Membrane Requirements

- » Membrane must be flexible and free of contaminants like adhesive, asphalt, facer, fasteners, plates, stones, and mold
- » Cut and remove seam overlaps, tapes, flashings and patches
- » Fold or roll membrane so it fits squarely on a standard 48" x 40" wooden pallet. Stack membrane to 3' high.
- » Secure membrane to the pallet

Insulation Requirements

- » Insulation must be full, intact sheets that are dry and free of adhesive, membrane or mold.
- » No wet or broken boards
- » Stack on dunnage or pallets to 4' high
- » Secure insulation by taping the stack together

Cylinder and Drum Requirements

- » All containers must be empty and placed on a pallet.
- » ALL CYLINDERS MUST BE DEPRESSURIZED PRIOR TO SHIPMENT. Cylinders that do not have the friable disk or knockout valve punctured will not be accepted.
- » Stretch wrap the pallet
- » ONLY standard (#40) cylinders of CAV-GRIP III, CAV-GRIP PVC, and Flexible FAST Dual Tank or small (#20) cylinders of CAV-PRIME will be accepted at the disposal facility.
- » Shipments must contain at least the required minimum quantity or a \$100 fee will be assessed. There is no maximum cap limit for the number of cylinders that can be shipped
- » Call the nearest CleanEarth recycling location and arrange shipping
