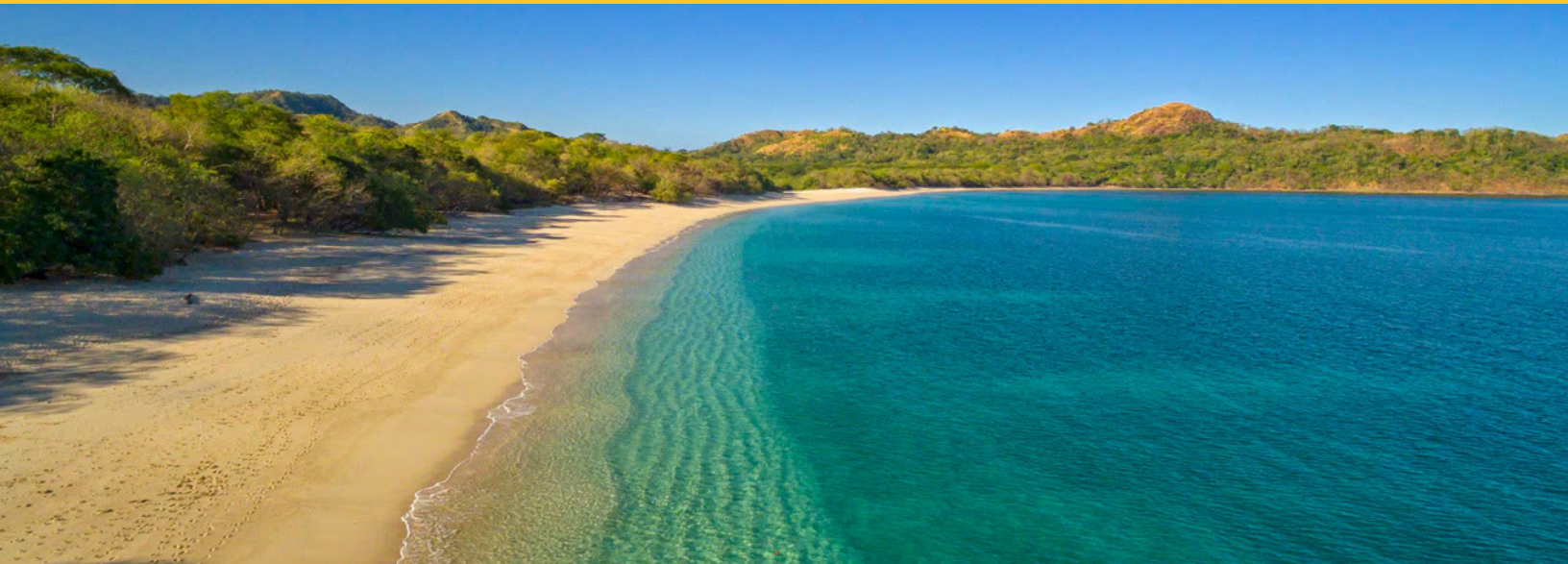


VERSICO CELEBRATES SUCCESS WITH KING'S COURT



King's Court Program

Through the King's Court program, Versico awards top-performing contractors with an annual all-inclusive trip for two as well as access to a variety of marketing and PR materials.

Example: A 20,000 sq. ft. Total System Warranty project composed of 90-mil EPDM fully adhered over two layers of 1.5" Versico Polyiso.

90-mil EPDM: 20,000 x .75 = 15,000
 Adhered System: 20,000 x .50 = 10,000
 Insulation: 20,000 x .25 = 5,000
 Total points = 30,000

HOW TO QUALIFY

Versico awards a select number of contractors with the King's Court distinction based on how many Excalibur Rewards points they accumulate throughout the year. During the year, contractors earn Excalibur Rewards points for installing Versico Membrane, Any type of Versico system, Versico Polyiso, Versico Metal, QA, SeamShield™ and 16' TPO. In order to qualify for King's Court, an authorized Versico contractor must earn 600,000 Excalibur Rewards points between January 1st and December 31st. Points are calculated based upon job completion date. The total system warranty projects are tracked through our warranty system and points are issued based upon system composition.
