Versico's specifications and details have been updated and uploaded to the Versico Roofing Systems website. Some highlights of the changes include:

- Added VersiGard® gray 60-mil thick non-reinforced membrane for EPDM.
- Revised numbers of perimeter sheets required for PVC membranes in Warranty Table V.
- Added Vapor Retarder design criteria for EPDM, TPO, PVC, VersiFleece and VersiFleece AC membranes.
- Modified testing language in Spec Supplement G-17-23 Electronic Leak Detection.
- Revised flood testing requirements for modular roof garden systems.
