


Ballasted Systems



Typical Applications

- Approved ballast
- VersiGard® EPDM with Quick-Applied Tape (QAT)
- 3 Versico Approved insulation
- 4 Approved roof deck

VersiGard Reinforced and Non-Reinforced 25 – 30 year Total System Warranties*

1. Approved Ballast:

1.5" nom. rounded water-worn gravel (ASTM C136 or D448)
Crushed stone with HP Protective Mat Minimum 18-psf pavers
2' x 2' x 2" pavers (maximum 80 lbs per unit)

2. Membrane:

45-mil VersiGard EPDM (25-year max.) 60-mil VersiGard Non-Reinforced EPDM 90-mil VersiGard Non-Reinforced EPDM

3. Versico Approved Insulation (loose-laid):

VersiCore® Polyisocyanurate SecurShield® Polyisocyanurate Insulfoam EPS Recovery Board (with acceptable insulation) XPS

Vapor Barrier (optional for new or tear-off only):

VapAir Seal™ 725TR VapAir Seal MD SureMB 90/120TG Base SureMB 90 Base Ply Polyethylene (by others) Other

Thermal Barrier (optional for new or tear-off only, not for use directly over concrete decks):

DensDeck®/DensDeck Prime SECUROCK® Gypsum Fiber Other

6. Deck:

22-gauge or heavier steel Structural concrete Wood plank Gypsum ½" Plywood Lightweight insulating concrete Cementitious wood fiber

7. Metal Edging:

Shop-fabricated metal Versico VersiTrim™ Metal by others

9. Construction Type:

New Construction Complete Tear-off

10. Slope:

2" per foot maximum.

*Buildings up to 100' tall with 55-mph wind speed coverage. Projects requiring warranty wind speeds greater than 55-mph should be reviewed by a Versico representative. All products must be supplied by Versico to be included in the warranty coverage. All roof systems can only be accepted upon inspection by a Versico Field Service Representative. Versico reserves the right to change or enhance any of the above components due to specific or unique project conditions.
